MARTY (ACCARDO) (?) and UNIDENTIFIED MAN

The discussion centers around a former customer of MARTY'S, named CHARLEY, who had a nervous breakdown. CHARLEY owed MARTY 3 bills. ^{He} asks MARTY if he got his money. MARTY says the guy kept stalling him, but he finally received the money. MARTY described CHARLEY'S strange behavior before the breakdown and he says he thinks it was all brought on because CHARLEY thought he had cancer.

DORIS approaches from the distance and joins the conversation.

MARTY and the ~~UN~~ continue their conversation about CHARLEY. MARTY says that once a month he used to get together with CHARLEY for dinner, and that sometimes JOE and JOHNNY would join them. (Although it is not specifically mentioned, it sounds as if CHARLEY committed suicide). MARTY comments, that he was nervous and it was the quickest way for him to get out, that CHARLEY left a note, and that they knew he was going to do it. DORIS comments, well at a time like that he was temporarily insane. MARTY comment that there was really nothing to the cancer deal.

The UNIDENTIFIED MAN then proceeds to tell a story of and individual who he knew who thought he had cancer. He mentions that this was right after World War II. This individual thought he was going to die. He planned some robberies and bank and payroll jobs. About two weeks before the jobs, his wife came down with a strep throat and the doctor was called in. The doctor examined this individual and it was determined that a simple operation would cure his difficulties. This individual commented to the ~~UN~~ that if it wasn't for his wife's cold he might have been killed in one of these robberies.

DORIS tells GENE that DINO is about to lose his buildings. GENE says yeh, that's a shame. GENE says that maybe he will stop back on the way home and see DINO.

DORIS makes a few loving comments to ADOLPH, the dog.
