Mr. TO// LANNIGAN, Manager, Hotel Forrest, 220 West 49th Street, NYC, advised on 4/9/62, that the subject checked into Room 1406 at the above hotel with CAPPY GUILMENTO.

NY 3488-C² advised that at 1:55 p. m. GUILMENTO placed a long distance call to GL 7-7411. GUILMENTO indicated that the telephone was a Pennsylvania exchange. GUILMENTO contacted an unsub at the other end of the line, advising that he was in New York with RUSS overnight, would return in the morning. He asked how the weather was down there. Also stated, "Is my friend there?" GUILMENTO hangs up. BUFALINO asks why didn't he ask about NICK. GUILMENTO answers he had to hang up the other telephone was ringing.

At 3:25 p. m., GUILMENTO makes an outgoing call number not discernable, to unsub named JOE -- "What time are you going to be there? We'll all be there sometime this evening. See you later."

At 4:40 p. m. incoming call from individual named MIKE. CUI MENTO indicates he got into New York at 2 o'clock. Says he will be over to New Jersey later, mentions seeing MIKE at Julie's (PH).

At 5:45 p. m., BUFALINO and GUIUMENTO indicate they are departing for Julie's as they want to be there early as they want to get things going.
