The information furnished by WY 3488-Ch on 5/7/62, has again been re-evaluted and it is apparent that the information furnished by the source which is contained in the last paragraph of page one and the first six paragraphs of page two in relat does not pertain to the subject. It appears that the source reported on one IRVING MICAHNIK who used the facilities of this room shortly after the subject. activities described in the above paragraphs all pertain to MICARNIK.

On 7/30/62, PCI TOM LANNIGAN advised that IRVING MICAINIK, who is presently in Room 1406, is in the music business and comes from Detroit, Michigan. LANNIGAN knewof no relationship between MICAMNIK and the subject. It is noted that the telephone credit card number listed in relat is MICAHNIK's credit card.

At 7:05 p.m., an unknown female entered the room and the name RUTH BROWN was mentioned. While the television was on, BUFALINO and the unsub talked about record productions and he mentioned that IRVING was going to California in two weeks. He and the unsub also talked about the union and the AGPA (ph). The female formerly entertained at the Town Hill Club (ph) and she had a record which was currently on the market. However, the name was not mentioned.

The female, who appeared to be a Negro indicated she was working at the Baly Grand Club (ph) in Brooklyn.

During their conversation, the subject received a phone call at 7:16 p.m. and he said that he was busy and leaving soon. He told the caller that IRVING manages name groups such as the Hurricanes, DELL SHANON (ph), etc.

After the caller hung up, BUFALINO identified him as MARK ALLEN (ph) and he described him as a fag.

The name of BUFALINO's female companion sounded like "Birdie Green" (NYO indices negative).

After the subject and GREEN apparently engaged in sexual activities, they left the room at 8:55 p.m. and there was no further activity.

The only activity reported by the source on 5/8/62 was a call made at 9 p.m. to an unsub female and the room occupant asked her to come over. She indicated she could not and the occupant apparently spent the rest of the time in the room listening to television. At 11 p.m., he left the room and there was no further activity.

On 7/26/62, PCI TOM LANNIGAN advised SA JOHN B. MEADE that the subject or his associates have not stopped at the hotel recently and he has received no reservation request from the subject. LANNIGAN indicated that should he receive any information to the effect that BUFALINO was in the hotel or planning to come to the hotel, he would notify the NYO.
