FOR INFORMATION OF LAS VEGAS, MIAMI ADVISED ON DEC. 10, 1976, THAT DEA INTERVIEWED AN UNIDENTIFIED SOURCE IN THE WITNESS PROTECTION PROGRAM CONCERNING ACTIVITIES OF SAM CAGNINA, AND WHETHER OR NOT CAGNINA WAS INVOLVED IN ROSKIL. SOURCE INFORMED DEA THEY HAD THE WRONG "SAM", AND SUGGESTED SAM CALABRESE, WHOM SOURCE THOUGHT WAS INCARCERATED IN RICHMOND, VA., PENDING FEDERAL PROSECUTION. CALABRESE CURRENTLY IN RICHMOND FOR JURY TRIAL, BUT UNAVAILABLE FOR INTERVIEW DUE TO TRIAL AND IS TO RETURN TO LAS VEGAS, NEVADA, ACCORDING TO MARSHAL'S OFFICE RICHMOND, VA., ON DEC. 15, 1976. CALABRESE'S HOME ADDRESS IS

ROSKIL, OOJ, OO: MIAMI.

DEA, MIAMI ADVISED DECEMBER 10, 1976, THAT IN TALKING TO AN UNIDENTIFIED SOURCE IN THE WITNESS PROTECTION PROGRAM, THE SOURCE WAS QUESTIONED ABOUT THE ACTIVITIES OF SAM CAGNINA AND WHETHER HE WAS INVOLVED IN ROSKIL. SOURCE INFORMED DEA THAT THEY HAD THE WRONG "SAM" AND SUGGESTED THAT SAM CALABRESE, PRESENTLY IN CUSTODY, RICHMOND, VIRGINIA, PENDING TRIAL IN FEDERAL COURT, COULD HAVE INFORMATION RELATING TO ROSELLI MURDER. CALABRESE IS REPUTED TO BE FROM LAS VEGAS, NEVADA, WHERE HE HAD NUMEROUS LCN CONNECTIONS. IT IS NOTED JOHN ROSELLI WAS THE CHICAGO LCN REPRESENTATIVE IN LAS VEGAS AND THE WEST COAST.
