During the week of 2/5/79, Chicago "BURGMURS" case Agent, Miami "ROSKIL" case Agent and Bureau Supervisor POMERANTZ reviewed "GANGMURS" files at Headquarters in an effort to evaluate the data obtained from the "GANGMURS" program. Approximately 52 murder files were reviewed at Headquarters, bearing in mind that the primary intent of the "GANGMURS" investigation was to determine whether an organized group of assassins exists in the United States conducting "hits" at the request of the LCN hierarchy.

The following three conclusions were drawn from the available evidence:

1. The majority of "GANGMURS" victims were hits conducted independently of each other.
2. Although .22 caliber weapons appear to be the weapon of choice in numerous gangland murders, there is no evidence to indicate that one or two "hitters" travel across the country for the LCN specializing in .22 caliber weapon murders.

the old members because he was tired of taking the crumbs. Source feels that DI SANTIS or ALLEMAN could have killed NICOLETTI.

ACHILLES advised he feels HARRY ALLEMAN was given contract on NICOLETTI.

Anonymous caller identified LOUIS EBOLI as killer.

TAMARA RAND

RAND threatened to reveal business dealings of GLICK. RAND was shot by .22 automatic at residence in San Diego on 11/9/75.

ACHILLES advised contract issued by GLICK and carried out by HARRY ALLEMAN and "CORKY". CORKY unidentified.

AUGUST MANIACI

Found murdered by .22 caliber automatic next to automobile at residence in Milwaukee, 9/11/75.

ACHILLES advised that Milwaukee LCN boss FRANK BALISTRIERI ordered it.

Witnesses positively identified CHARLES NICOLETTI as driver. One witness identified PAUL SCHIRO as shooter. Also a police source said SCHIRO killed MANIACI. SCHIRO fit composite drawing; however, witness failed to identify SCHIRO in a live lineup.

A second FBI source advised MANIACI killed because he disagreed with BALISTRIERI. Milwaukee surveillances in 7/77 noted

meetings between BALISTRIERI and STEVE DI SALVO (underboss).
DI SALVO was then observed meeting with PAUL SCHIRO at race track.

MANIACI's girlfriend said DI SALVO and MANIACI argued one week prior to his murder. MANIACI told her to get a silencer for a .38 and said "I've got to get that little SOB before he gets me". Weapon used was purchased at Tamiami Gun Shop, Miami, Florida, at the same time gun purchased which was used in SAM GIANCANA murder.

RAY RYAN

RYAN killed 10/19/77, while entering his automobile. A bomb was detonated in a vehicle adjacent to his. The bombing took place at Evansville, Indiana.

ACHILLES advised that FRANK AIUPPA ordered hit and it was carried out by SCHWEIHS.

San Francisco source advised murder handled by MARSHAL CAIFANO and RON D'ANGELES (The Wizard).

ALVA JOHNSON ROGERS advised CAIFANO probably requested it; however, hit would have been carried out by JOEY LOMBARDO.

RYAN testified against CAIFANO and CHUCKIE DELMONICO in extortion case. Hit was a result.

SAM GIANCANA

GIANCANA found murdered in his basement by .22 caliber automatic on 1/19/75 at Oak Park, Illinois. Weapon equipped with a silencer and purchased at Tamiami Gun Shop, Miami, Florida, along with weapon used in the MANIACI killing.

GIANCANA was having an affair with TONY SPILOTRO's wife - possible motive.

Power struggle going on between GIANCANA and TONY ACCARDO for leadership of Chicago LCN.

ACHILLES stated following responsible: FRANK AIUPPA, TURK TORELLO, JOE LOMBARDO and "NIGGER JOE" AMATO.

EDWARD ANTHONY BUCCIERI

BUCCIERI killed 5/12/75 in parking lot of Caesar's Palace Hotel, Las Vegas, Nevada. He was shot by .22 caliber automatic.

BUCCIERI assisted ALLEN GLICK in obtaining 142 million dollar loan from Teamster's Pension Fund. GLICK refused to give BUCCIERI a finder's fee and they argued. BUCCIERI threatened to go to the Gaming Commission and the Grand Jury.

ACHILLES advised killing ordered by ALLEN GLICK and committed by SPILOTRO, HANSEN and SCHIRO.

EDDIE LAZAR

LAZAR found murdered 2/19/75 in parking lot at Phoenix, Arizona. He had been shot by .22 caliber weapon.

HOWARD WOODALL, Phoenix con-man, advised that in 1972 his attorney BURTON HIRSCH attempted to arrange "hit" of STAN TANNER for "making waves". HIRSCH suggested bringing in hit men from Chicago nicknamed "HOP-A-LONG" and "ONE-EYED JACK".
