Reference to made to my communication dated October 2, 1962, your reference BZ/BAFinjj, in the captioned matter.

Dr. Ernesto Aragon y Godoy, 233 Bast Sizty-ninth Street, New York City, who is a delegate of the Cuban Revolutionary Council (CRC), conferred with Dr. Jose Miro Cardona, head of the CRC, relative to the information concerning the missile bases and electronic equipment being installed in Cuba which reportedly was being used by the Castro regime to detect and interfere with launchings from Cape Canaveral, Florida.

On November 4, 1962, Dr. Aragon furnished a document distributed by the CRC dated September 5, 1962, at Miami, Florida. This document was prepared by the CRC based on information which the CRC received from individuals who had recently come out of Cuba as exiles and from information received by the CRC through letters which were sent from Cuba.

Dr. Aragon also furnished a copy of an affidavit taken from one of the individuals interviewed by members of the CRC which sets forth information this individual had personally observed or knew from firsthand sources.

Translations of the above-mentioned documents are attached for your information.

Dr. Aragon further civised that this was the only information he had been able to obtain in this matter. He pointed out that information which the CRC receives from individuals inside Cube in many instances cannot be individuals inside Cube in many instances cannot be verified. Dr. Aragon also stated that he had inquired of individuals within the CRC relative to the type of electronic individuals within the CRC relative to the type of electronic equipment which might have been installed or possibly would be installed in Cuba, and he had been informed that they had no specific details concerning these alleged installations.
