Re Dallas airtel to Director dated 6/2/92.

The Dallas request to microfilm its John F. Kennedy (JFK) Assassination files has been carefully reviewed by the Information Management Division (IMD) and the Criminal Investigative Division and it has been determined that FBIHQ is unable to support the Dallas request for funds. Accordingly, Dallas should forward its original files to FBIHQ.

Since Dallas will be relinquishing its only copy of the assassination files, IMD will provide timely response (including facsimile transmissions) to any Dallas request for a file review or for specific documents in connection with any ongoing investigative activities.

Time is of the essence since the JFK task force is utilizing 30 summer employees to prepare the inventory of our files. FBIHQ therefore needs to inventory and process the original Dallas files identified in Dallas teletype dated 1/28/92. In addition to that material, files 134-307, 134-308, and 105-1435 concerning Marina Oswald, and the 3 x 5 and 5 x 8 Special Indices also need to be sent to FBIHQ.

Dallas is requested to send its original files to Mr. Bill Shackelford, Room 4336, no later than 7/20/92, but sooner, if possible. Questions concerning this airtel can be directed to P. Grant Harmon, Jr. at (202) 324-9260.
