Dear Mr. Marsden:

On 10/26/92, President George Bush signed "The John F. Kennedy (JFK) Assassination Records Collection Act of 1992." This Act requires that Government records related to the assassination of President Kennedy be sent to the National Archives for public release. It was passed because of the renewed public interest in the release of all JFK records and it facilitates the release of information normally exempt from disclosure under Executive Order and/or the Freedom of Information Act. We have enclosed a copy of the Act for your review.

The FBI has established a task force to process the JFK assassination records. The FBI's goal is to maximize release of information and we propose to seek postponements (i.e. matters withheld) only where there is compelling justification for doing so. In 1978, we processed all of our JFK records and disclosed all of the information which you had provided but withheld your company's name. We believe that we should now disclose that name where it occurs in our assassination files. This planned release is limited to the JFK investigation and the documents defined by the 1992 Act and should not affect any future handling of your organization's information concerning other subjects.
