Mr. Barry Harrelson of your office has advised us that some of your documents make reference to the relationship between the FBI and the code names FEDORA and [SHAMROCK]. Mr. Harrelson [S] stated that the CIA is researching whether to release certain information relating to these two code names. (X)

The FBI requests that you allow us to review and comment upon all CIA documents that make reference to the FBI's relationship with FEDORA or [SHAMROCK]. We have an interest in [S] both matters and would like to comment on issues which may concern both the CIA and the FBI. (X)
