For the information FBIHQ, in Boston teletype to the Director, dated January 28, 1992, captioned JOHN F. KENNEDY Assassination (Bureau File Number 62-109060), the Boston Division informed the Bureau that it was unable to locate Boston file 62-3861. This file has now been located and pursuant to the instructions received from SSA GRANT HARMON, FBIHQ, the three original serials contained in this file are being forwarded to the Bureau as enclosures to this airtel.

For the further information of the Bureau, the Boston Division has conducted five searches for Boston file 175-112. This file is entitled "Assassination of President JOHN F. KENNEDY". According to Boston teletype to the Director dated January 28, 1992, Boston file 175-112 was characterized as follows: "This file does not reflect any investigation at Boston. It is a repository for correspondents and public record information regarding the assassination." The Boston Division obviously reviewed this file shortly before submitting the above mentioned teletype to FBIHQ. Since that time five separate searches have been conducted attempting to locate it so it could be sent to the Task Force at FBIHQ. These searches have proved negative and the most recent one was conducted by MDE MARGARET MUNROE on June 14, 1994. This search included checking all logical places where the file could be located including closed files, all Squad Rotors, the Informant Room, the SAC and ASAC's offices but the search proved negative as it has so many times in the past. Boston file 175-112 is listed on the Boston missing file list.

Boston teletype to the Director dated January 28, 1992 also mentioned that Boston file 157-55 also pertained to JOHN F. KENNEDY but was unable to be located. Since that time there have been at least two additional attempts to locate 157-55 with negative results. The most recent attempt to locate 157-55 occurred on June 14, 1994 and the search was conducted by MDE MARGARET MUNROE. This search included all of the places mentioned above for the search for Boston file 175-112. Boston file 157-55 is also on the Boston missing file list.

On June 14, 1994 the Boston Division conducted a FOIMS check on the following subjects:

1. JOHN F. KENNEDY Assassination
2. JFK Assassination
3. Assassination of President John F. Kennedy

4. President John F. Kennedy Assassination

5. JFKARCA

These FOIMS Indices checks located no additional records concerning captioned matter. These FOIMS checks disclosed information contained in Boston File 62-HQ-109060 which is the Boston Division Control File pertaining to captioned matter.

PLA Boston also checked to see whether the Boston Division had any files pertaining to "89A-DL-60165" and this check proved negative.

On June 15, 1994 SSA GRANT HARMON contacted PLA Boston and requested that a search be conducted for Boston File 52-8794. SSA HARMON advised that this file was captioned "UNSUB POSSIBLE THEFT OF JOHN F. KENNEDY AUTOPSY PHOTOGRAPHS". MDE MARGARET MUNROE and Closed File Clerk ROBERT EMERSON made an effort to locate this file with negative results. They determined based upon the date other files around this file were opened that the file probably was opened around 1985. MDE MUNROE checked the FOIMS Index in an effort to assist in locating the file but it was not indexed into FOIMS. Neither was the file on any file destruction list. MDE MUNROE then conducted the same type of search for 52-8794 that she conducted regarding the other missing files and this search proved negative. PLA Boston does not know where this file is located.

Boston PLA JOHN MICHAEL CALLAHAN, Jr. coordinated the Boston Division efforts regarding captioned matter. The actual file searches and various indices searches were conducted by various support personnel in the Boston Division.
