SF performed the following actions on 6/15/94 to ensure all pertinent records have been located and forwarded to HQ:

1. FOIMS was re-searched on all previously requested subject matters, with negative results.

2. FOIMS was queried for file 89A-DL-60165, with negative results.

3. Manual indices were re-searched on all previously requested subject matters. This search revealed three files which did not appear on previous searches: 105-12872, 62-5071, and 175-17. These files will be forwarded to HQ from WRCSC, Pocatello.

4. Files listed on previous search slips were compared with communications forwarding files to HQ. It was determined that all files identifiable with this matter had been forwarded to HQ with the exception of 62-5069. HQ had previously advised there was no need to send this file. This file will now be forwarded to HQ from WRCSC, Pocatello.
