FBIHQ teletypes referenced in Bureau teletype of 6/14/94 were reviewed, and all files identified previously by Louisville as being responsive were again inspected. Louisville files 89-63, 44-542 and 105-620 were determined to have been submitted to FBIHQ previously, and no additional material has been received or added to these files since the time of submission. (4)

Louisville does not maintain a file corresponding to UCFN 89A-DL-60165. FOIMS was requested for references to "Assassination of President JOHN F. KENNEDY" without locating references additional to that previously reported.

Louisville is not aware of any relevant files not previously reported and transmitted.
