Please be advised that all files and "see" references relating to the JFK assassination have been previously shipped to FBIHQ.

Re Tampa's airtel dated 5/4/94, file 58-207 (relating to RICHARD SECORD) is still missing. Tampa has been unable to locate this file and is requesting a search be done of all the Tampa files that were sent to the Bureau in relation to the JFK Assassination prior to the (JFKARCA) 1992 act.

Enclosed are copies of Search Slips for the subjects searched by the Tampa Division. Also enclosed is volume 2 of file 183A-263 Sub 19, which was just located.

No further documents have been located to date.
