For information of the Bureau, all Detroit Division material responsive to captioned subject has previously been submitted to the Bureau. To date, the Detroit Division remains unable to locate Detroit Files 100-2050-SUB 2-C and 100-13420-SUB 1 and 2 to which four intercepts were indexed. Per conversation with File Supervisor MARINA K. MAKRIS, Detroit Files 100-2050-SUB 2-C and 100-13420-SUB 1 and 2, may have been destroyed, although they are not logged in the appropriate classification destruction book maintained by the Division and will remain on locate.
