(5) During the interview he handed over a slip of paper, the original of which is in the possession of the State Department reprecontative, on which he wrote that Ruby was an old friend of Corold. that Covald's wife was a Mill worker and that a group of people directly assisted in the murder (apparently a reference to the assassination). The British reported that Sergievsky appeared servous and spoke of having been given pewdered poison when 11 years of age, which had the offect of reducing dis enygen starvation of his brain. He also spoke of experiencing mental blanks and to have undergone a brainmenhing procom in which a form of monthypnosis was induced by gmoking disguised opium cigaretts.
