In 1951 if was reported that Sauvage was a member of a small group of individuals close to Louis Dolivet who was refused reentry to the United States due to his suspected communist and Comintern background.

According to a statement filed with the Department of Justice, Foreign Agenta Registration Section, the French Press Agency (FPA) in January, 1954, listed Leo Sauvage, 270 West End Avenue, New York City, as an employee of that agency. In May, 1954, while Sauvage was still employed by the PPA, it was reported that the chief of the Washington Bureau of the Soviet Tass News Agency utilized personnel of the FPA to secure intelligence information. In September, 1956, it was alleged that one Leon Sauvage, 28 rae Marcel Royar, Genevilliers, France, was one of a number of individuals employed by the French Communist Party Headquarters, Paris, France. R is not known if this individual is identical with captioned author. (64-200-231-1559 page 5)

The March, 1964, issue of "Commentary," a monthly magazine published by the American Jewish Committee, contained an article by Sauvage entitled "The Oswald Affair." This article attacks the findings of the Warron Commission concerning the assassination of former Presisent John F. Kennedy and suggests that Oswald was unjustly presumed to be guilty of the assassination due to prejudiced press and television

Results of PARISH's investigation and interview are contained in the LHM, 5 copies of which are enclosed.

From this contact with PARISH and further checking of Special Branch records, New Scotland Yard, it would appear subject is an inveterate letterwriter with some mental instability.

MR.KEITH HOSKINGS

On April 20, 1970, a check of records of New Scotland Yard, London, England, reflected that KEITH HOSKINGS was born October 8, 1928, in St. Kitts, British West Indies. He arrived in the United Kingdom in 1958 and resides with his mother at 16, Gap Road, Wimbledon, London. S.W. 19. In 1960 he was arrested and convicted for theft and as of April 27, 1970 was about to be arrested again by Metropolitan Police, London, for larceny of money from his employer.

On April 24, 1970, Detective Sergeant FRED PARISH, New Scotland Yard, London, interviewed HOSKINGS at his residence. He described HOSKINGS as a white male with West Indian accent. He has persisted in saying to the police that he was not well enough to stand trial for his present offence of larceny from his employer and it is believed that the letters he has written to the F.B.I. at Washington and Dallas, as well as letters to ' American Embassy, London, U.S. Air Force Headquarters, England, and New Scotland Yard, London, have all been an attempt on his part to say that he has been cooperating with New Scotland Yard and the F.B.I. in solving major crimes, which he hoped would act in mitigation for his current offense of larceny from his employer.

When interviewed by Sgt. PARISH, he professed intimate knowledge of all the current major crimes in London, including a kidnaping and murder case and an espionage case currently being tried. He also claimed to have been a member of the Mafia sent to England.

Sergeant PARISH is of the opinion that because of subject's mental instability he thought he mightebe immediately brought to the U.S. to assist U.S. authorities, thus saving himself from being arrested and sentenced in London.
