REQUEST FOR BUILDING PASSES

FURPOSE: To request that temporary building passes be issued to the six members of the HSCA listed below who regularly appear at PBIHG pertaining to their assignments in reviewing pertinent FBI files. These passes would be temporary, for a period not to exceed 60 days since it is anticipated that full field investigation of these individuals will soon be requested by the Department of Justice.

RECOMMENDATION: That building passes be issued to these six representatives of the HSCA on a temporary basis.

DETAILS: The HSCA was established by the 94th Congress in September 1976, and was reconstituted by the 95th Congress for a two-year period in March, 1977. (House Resolution 433).
