Reurgirtel 11/7/63 enclosing HI-5 Report Number 27 entitled "Personalities in Radio Moscow Known to Viaduct." Enclosed are three copies of self-explanatory letterhead memorandum dated 8/5/64 at Washington, D. C., and three copies of a photograph of six personalities associated with Radio Moscow as of 6/60. Furnish two copies of enclosed letterhead and photograph to your sources and request that Viaduct be interrogated in accordance with requests in the letterhead. (S)

For your information not to be disseminated outside your office, Lee Harvey Oswald is believed to have participated in a taped interview thought to have been broadcast by Radio Moscow on a Sunday in late 1959. Documents in Oswald's handwriting made reference to such broadcast in which Oswald claimed to have spoken of his experiences as a tourist in Moscow. The name of Lev Setyaev, his office telephone number and his residence address, as well as the inscription "Radio Moscow," were found in Oswald's address book and on a slip of paper in Oswald's wallet. Lev Setyaev is believed to be identical with person of same name who is referred to in the enclosed letterhead. (In furnishing results of requested interrogation of Viaduct, furnish sufficient copies for inclusion in Bureau's file on Oswald (Bufile 105-82555) and in Dallas' file of same case (DLfile 100-10461). (S)

(For Dallas there is enclosed a copy of HI-5's Report Number 27 referred to herein. For your information Viaduct is a low-level KGB agent who defected to the British in 9/63. His bonafides have not been established, and at the present time, he is suspected to be furnishing disinformation to the British. For Dallas' information this communication relates to Bureau airtel and radiogram to Anchorage dated 7/29 and 7/31/64, respectively. (S)

**RE: VIADUCT  
ESPIONAGE - RUSSIA**

Reference is made to Report Number 27 captioned  
 "Personalities in Radio Moscow Known to Viaduct." (S)

In this connection there is enclosed a photograph  
 of six individuals who were reportedly members of the North  
 American Section of Radio Moscow as of June, 1960. The date  
 of the enclosed photograph is unknown.

The individuals depicted in the enclosure, reading  
 from the viewer's left to right are reportedly identifiable  
 as follows: (1) Nikolai Sergeyev; (2) Annette (Anita)  
 Setyaeva, nee Zugoff formerly known as Annette Goldsteina  
 (Goldstein) and Annette Henkina (Henkina); (3) Joseph  
 Adamov; (4) Annabelle Ducar; (5) Sergei Rudin; and (6) Lucy  
 Pravdina.

Joseph Adamov is believed identical to the person  
 of same name who is referred to in paragraph two of Report  
 Number 27 and Annabelle Ducar is believed identical to the  
 person referred to in paragraph six of the report. Sergei  
 Rudin is likely identical with the Rudin referred to in  
 paragraphs 11 and 17 of the report. (S)

Annette Setyaeva is believed to be identical with  
 the Annette Goldstein (Henkina) referred to in paragraph 14  
 of the report. (S) This person was born October 18, 1919, at  
 Lake Stevens, Washington, to William E. Zugoff, a Russian  
 national, and Lillie May Edwards who was born at Northland,  
 Michigan, in 1902. Setyaeva's mother is presently known as  
 Lillie May Rahn and resides at Kotchikan, Alaska.

RE: VIADUCT

Annette Zugoff was reportedly taken to the Soviet Union by her father in 1934 and has since acquired Soviet citizenship. She is believed to have returned to the United States. (S)

Annette Zugoff has been employed for approximately 20 years as an announcer by Radio Moscow. She is believed to have been married first to one Goldshteyn (Goldstein) by whom she has a daughter, Marina, currently aged 22 - 23. She was reportedly next married to one Rankin, also known as Rhenkin, who for a time was employed, as Viaduct indicates, as an announcer and writer at Radio Moscow. Annette Zugoff Setynova has a son, Kostin Rankin, currently aged 8 - 9. Her daughter, Marina, according to Mrs. Rankin, is married. (S)

Annette Zugoff is currently married to Lev or Leo Setynov who is said to be an announcer at Radio Moscow.

It would be appreciated if the enclosed photograph be displayed to Viaduct to determine if he can identify the personalities depicted therein and if he can furnish any further biographic data concerning them. We would be interested in having Viaduct's comments concerning the age of the photograph and his views as to the quality of the picture. We are particularly interested in developing any information in Viaduct's possession concerning Annette Zugoff's first husband, Goldshteyn (Goldstein), and her daughter Marina. We would be interested in knowing Goldshteyn's occupation and are desirous of obtaining a physical description of Annette Setynova's daughter, Marina, and any available information as to the identity of her husband. (S)

We would also appreciate any biographic data, including descriptive material, that Viaduct may be able to furnish concerning Lev or Leo Setynov. (S)
