Director Freeh:

Tomorrow, 5/7/96, the JFK Task Force (JFKTF) will transfer an additional 16,679 pages of JFK documents to the National Archives and Records Administration (NARA). transfer will bring the total number of pages sent to NARA to 641,128.

Tomorrow's transfer will consist of files reviewed by the House Select Committee on Assassinations (HSCA) as it explored various assassination conspiracy theories. include those on organized crime figures Angelo Bruno, Gabriel and Sam Mannarino, as well as other persons of interest to the HSCA, most notably Maurice Lerner, John Orion Pittman, and Thomas Eli Davis.

Of the 16,679 pages transferred today, 4,404 contained postponed information ranging from one word or item on a page to more extensive postponements. Ninety-one were withheld because the FBI postponed them in their entirety. There were another five pages withheld in their entirety because they contained IRS information, the release of which is prohibited by the Act. Another 256 pages were withheld because the FBI is awaiting word from another government agency or a foreign government as to whether their contents can be released.

Many of the postponements in the files to be released tomorrow were taken to protect sensitive sources, particularly those who provided information regarding organized crime activities. Other postponements involved grand jury material that has not been unsealed. The FBI will work with the Department of Justice to have grand jury records made public where appropriate, and take other steps to reduce the amount of postponed materials in these files, as part of its continuing effort to maximize disclosure of information in its JFK records.
