Title: JOHN F. KENNEDY ASSASSINATION RECORDS COLLECTION ACT OF 1992

Synopsis: Response to OPCA EC dated 6/19/97.

Details: In April 1996, Legat Bern sent captioned file to FBIHQ to be microfiched; therefore, Bern is unable to provide full details of activity on this matter. Legat Bern, however, does recollect that a search of Bern records was conducted, either by FBIHQ or Bern, and that certain references to the JFK assassination were located in Bern files. These references pertained to information received from a confidential Swiss source. Subsequently, Bern obtained the consent of the Swiss source to release certain, but not all, information to the JFK Assassination Review Board.

Legat Bern can advise that JFK Task Force is fully aware of the information contained in Bern files that refer to the JFK assassination and that whatever information can be released has already been released.

Leget Bern regrets not being able to provide further details and suggests the OPCA may want to locate the file at FBIHQ for that information.
