Synopsis: Mexico City indices regarding Judith Campbell Exner negative.

Administrative: Re Bureau EC to All Field Offices and All Legats, dated 06/19/1997.

Details: A review of Mexico City automated indices were negative for the name Judith Campbell Exner, and appropriate aliases. It is to be noted that the only records available for searching at Legat, Mexico City are automated records via FBINET.

Legat, Mexico City was automated on 11/9/88, and all records prior to this time have been sent to FBI Headquarters for storage, to include all manual indices records. If further record searches are required in this regard, a request will need to be made through FBI Headquarters, FSU/FISS/RDA/MS/4933, Richard Singleton.

It is to be noted that the deadline date for this information was 7/10/97. Legat, Mexico City did not receive referenced EC until 7/24/97.
