Synopsis: Results of file check at Legat, Mexico City.

Administrative: Re OPCA EC to Mexico City, dated 7/22/97, received at Legat, Mexico City on 8/22/97.

**Details:** On 8/25/97, a review was made of Legat, Mexico City records. The file requested in referenced EC, 105-3701, is no longer maintained at Mexico City. A review of Mexico City's current records do not extend past 3/28/83, and the file 105-3701 does not appear in any of these records, therefore the exact date that this file was forwarded to FBI Headquarters is unknown.

Mexico City's records are all maintained for historical record and are not destroyed, but are placed in storage by FBI Headquarters. Legat, Mexico City was automated on 11/9/88, and all records prior to this time have been sent to FBI Headquarters for storage, to include all manuel indices records. If futher record searches are required in this regard, a request will need to be made through FBI Headquarters, FSU/FISS/RDA/MS/4933, Richard Singleton.
