Synopsis: Conducted indices search for additional assassination related information.

Administrative: Re Bureau EC, dated 7/8/98.

Enclosures: Enclosed for FBIHQ are nine (9) original index cards pertaining to John F. Kennedy, Lee Harvey Oswald and Jack Ruby and original FD-160 indices search slips.

Details: Per instructions from FBIHQ, Cleveland conducted an indices search for additional assassination related information concerning John F. Kennedy, Lee Harvey Oswald and Jack Ruby. No other information was located in our files pertaining to aforementioned individuals. All investigative files 44-265, 62-2488 and one (1) cross-reference (62-0-21442) were previously forwarded to FBIHQ for retention. FBIHQ was also advised that Cleveland file 62-1848 had been destroyed in November, 1977.

Also, a search of the indices to the central record system maintained in the Cleveland Office revealed no information in our files pertaining to Marguerite Oswald, Marina Oswald, Ruth Hyde Paine, Michael Ralph Paine, George de Mohrenschildt, Clay Shaw and David Ferrie.
