Howard,

The attached August 19, 1996 letter to the Director, delivered today (8/21/96), from the Assassination Records Review Board (ARRB), advises of determinations concerning JFK records. A seven day period for appeal to the President exists, upon receipt of this letter.

The details of documents with possible appeal issues of the 107 documents (and duplicates thereof) have been set forth in the Information Resources to Criminal Investigative, National Security, and Office of General Counsel electronic communication dated August 19, 1996. Four documents are related to a privacy matter, which was noted in the Mr. Patrick W. Kelley to Mr. William Leary, Senior Director, Records and Access Management, National Security Council dated August 12, 1996.

Other documents listed in the attached letter either provide no appeal issues as the JFK Task Force was in agreement with ARRB determinations or the documents are duplicates of those previously decided by the ARRB and are now without appeal issues.
