Reference is made to my note to you dated 12/21/95, addressing five FBI documents containing Swiss Government information, indicating a forthcoming letter from the Assassination Records Review Board (ARRB).

The above mentioned letter, delivered from the ARRB yesterday, is attached together with Hartingh's opened copy; it advises of the determinations concerning FBI records containing FBI informant identities and information. A seven day period for appeal to the President exists, per this letter. The details of the 47 documents (20 originals and 27 duplicates) at issue in this letter have been set forth in John A. Hartingh to Mrs. Morris memoràndum dated 12/18/95, which recommended that CID and NSD advise you of their positions on release of the information described.

The last two pages of the attached ARRB letter list mutual consent release documents as of 12/13/95. These numbers will be verified upon receipt of corresponding FBI document numbers from the ARRB.

I understand you met on this matter this morning. Please advise me or John Hartingh if we may assist you further in this matter.
