The purpose of this note is to provide an update on the transfer of JFK documents to the National Archives and Records Administration (NARA), and the continuing dialogue between the Task Force and the Assassination Records Review Board (ARRB).

On 11/3/95, the JFK Task Force is set to transfer more than <u>11,380 pages</u> of files reviewed by the House Select Committee on Assassinations (HSCA) as it examined various conspiracy theories. The files released at this time include organized crime figure Carlos Marcello, anti-Castro activist Orlando Bosch Avila and other persons of interest to the HSCA.

Discussions have continued with the ARRB concerning postponements of informant true names, symbol numbers and "singular" information that would identify informants if disclosed. The ARRB has upheld the postponement of the numeric portion of symbol numbers, but not the prefix or suffix or singular information, for those we appealed to the President. We will pursue protection for other symbol numbers in that manner and will have to attempt to obtain protection for true names and singular information. The informant issues are to be addressed again at the ARRB meeting on 11/13 - 14/95.

The ARRB, thus far, has denied protection for cooperative citizens whose identities were protected at their request and for neighborhood sources, and other "established sources" who provided information under a grant of confidentiality, but were not informants. A separate memo is being submitted on the latest determination on these issues in nine specific documents to ascertain if appeal is warranted.
