DETAILS: Unit Chief P. Grant Harmon has been involved in the management of the JFK Task Force since its origin in 1992. He is currently under a Phase II transfer to WMFO with a release date of 9/30/94, and a requirement to report by late January, 1995. This communication requests WMFO's concurrence with respect to delaying Mr. Harmon's reporting date until 5/1/95.

The JFK Task Force has made considerable progress toward transferring all pertinent documents to the National Archives and Records Administration (NARA) under the "President John F. Kennedy Assassination Records Collection Act of 1992." Almost 600,000 pages of materials are now at NARA; however, the Task Force continues to work on the FBI's last major segment of
