## JFK Assassination Records

Your letter of August 21 1995 refers. I attach a copy for ease of reference.

2. Our comments on the documents in the series 62 are as follows:

Item 182 Cleared

Item 193 We request that the sentence beginning "MI5 advised today" be blanked out on grounds of personal sensitivity (ie adverse character assessment).

Item 1440 Cleared

Item 967 Cleared

Item 1793 Cleared

Item 1870 Page 1 - We request the sentence beginning "My cable of 11/27/63" be blanked out. Ditto the whole sentence in para 3 "According to MI5 while". Also the last sentence of the para at the top of page 2 "It is the general feeling". Same grounds as above. (5)

Items 2068 and 2109 - We ask that the whole of our reporting on (HASSAN) to be withheld. This is an intelligence report of the kind we would not release in the UK. The information it contains was provided in confidence.

Item 2404 Cleared so far as we are concerned.
