Legat Paris has requests outstanding with the (DST, DGSE, and Prefecture of Police regarding all documents supplied by fax to Legat Paris. Each agency has advised that decisions must be made at high levels (for example, DGSE's Director must review the matter, and he is currently out of town; the package for the Prefecture of Police had to be conveyed in the form of a written formal request and hand-delivered to the Prefect's Office). We note that the Sureté Nationale no longer exists. (5)
