
Dear Ms. Keeley:

(U) This is in response to your request that the enclosed Federal Bureau of Investigation documents be reviewed for possible release under the provisions of The President John F. Kennedy Assassination Records Collection Act of 1992.

(C) The documents have been reviewed. The information may be released with the exception of the information bracketed in green. The bracketed information cannot be released at this time. The mail intercept found within the documents was a joint United States/German operation. The German Government has noted that this type of information is still considered classified.
