(U) This is in response to your request that the enclosed Federal Bureau of Investigation documents be reviewed for possible release under the provisions of The President John F. Kennedy Assassination Records Collection Act of 1992.

(C) The documents have been reviewed. The information may be released with the exception of the information bracketed in green. (The mail intercept found within the documents was a joint United States/German operation. The German Government has noted that this type of information is still considered classified.) Additionally, information has been highlighted that would reveal the identity of an intelligence source. Please note that the acronyms CAS and DAD should be referred to the Central Intelligence Agency for review. The majority of information has been marked for postponement based upon personal privacy issues.
