DETAILS: For your information, the JFKARCA, which was passed by Congress in 1992, mandates that each Government agency transfer to The National Archives and Records Administration (NARA) all records maintained concerning the assassination of John F. Kennedy, to include those which were provided to the House Select Committee on Assassinations (HSCA) in 1978.

Under the terms of the Act, each Agency must provide original documents to NARA, and may postpone release of certain specifically defined types of information (i.e. classified information, informant identities, et al.). Postponed material
