**Details:** By EC dated 09/24/1996, FBIHQ requested certain serials from St. Louis files be forwarded to the JFK Task Force. The first file number listed was SL 92-258. It is noted 92-258 has been destroyed. Based on information furnished telephonically by LuAnn Wilkins, St. Louis is confident this should have been 92-158.

The enclosed serials refer to two microphone surveillances conducted out of the same file: John Joseph Vitale; Anti-Racketeering. Sub 1 and Sub 3 contain substantive paperwork while Sub 1A and Sub 3A contain log summaries. Both surveillances required only HQ approval and have not been sealed by a court.
