Title: JFK Records Collection Act of 1992 (The Act)

Synopsis: To advise FBIHQ of the results of requested Memphis research and to enclose the originals of specified pertinent serials for FBIHQ/JFK Task Force.

Enclosures: The following original serials were retrieved from Memphis Division ELSUR control file 66-823 and are forwarded to FBIHQ:

- Serial 58, an airtel dated 10/07/66, and
- 2. Serial 72, two separate summaries of two separate recorded conversations.

Details: The two serials referenced above have been maintained in a Memphis control file regarding electronic surveillance. The airtel pertains to a consensually recorded conversation in which the consenting party, Robert D. Vick, while wearing a concealed recording device, recorded his private conversation with attorney Zeno Thomas Osborn and others present. The first two pages of the enclosed summaries describes the conversation between Robert D. Vick and Zeno Thomas Osborn. The remaining five pages of the enclosed summaries pertains to the private conversation of Edward Partin and Ewing King.

With regard to the taped conversation between Robert D. Vick and Zeno Thomas Osborn, the conversation occurred on 11/11/63 at the law office of Zeno Thomas Osborn. The recording was made in connection with Memphis file number 72-50 (Bufile number 72-1543), titled James Riddle Hoffa; Zeno Thomas Osborn; LMRA, 1947 - IM; Conspiracy; OOJ. This investigation involved allegations that Zeno Thomas Osborn, acting as counsel for James R. Hoffa, directed Robert Vick, a private investigator, to approach Ralph A. Elliott, a prospective juror in Hoffa's
