Administrative: Reference letter from FBIHQ, dated 08/23/1995, telcall between Joseph L. Reyes, ALAT Caracas and Debbie Beatty, JFK Task Force Analyst, on 02/21/1996, and Caracas teletype, dated 06/26/1996.

Details: Referenced FBIHQ letter set forth a lead for Caracas to contact Venezuelan officials to obtain authority to release a small amount of information relevant to a George Demohrenschildt, WF 100-1689, Serial 251, furnished by Venezuela, Seguridad Nacional in 1957. In referenced telcall, it was agreed that Caracas should hold this lead in abeyance because of certain difficulties other Legal Attaches were having in obtaining similar authority to release information. FBIHQ advised that a board would meet to discuss a specific mechanism for obtaining authority from foreign governments to release information relevant to the JFK assassination. As a result, Caracas has had this lead in pending inactive since that time.

As instructions have not been received to date, Caracas considers this lead covered.
