**Synopsis:** (U) On 10/11/1996, the Assassination Records Review Board (ARRB) formally advised by letter to the FBI their determinations on FBI documents. The FBI has a limited mandated time frame in which to appeal these decisions.

**Enclosures:** (U) Evidence provided by the JFK Task Force (JFKTF) to support maintaining the postponement and the documents with postponements highlighted.

**Details:** (U) On 10/11/1996, the ARRB formally advised the FBI of the determinations voted by them on FBI documents at a meeting held 9/27/1996. The ARRB letter listed 174 documents for which the ARRB made determinations. The FBI is in agreement with the ARRB's determination to postpone or open information in 64 of the documents. Of the remaining documents, the ARRB voted to either sustain some, but not all of the information requested by the FBI or open the documents in full. The release of the information in these documents will reveal the identities of 223 individuals who were described as potential criminal informants (PCI), security
