**Synopsis:** (U) Request the issuance of a permanent unescorted building pass for Mr. Joseph R. Masih.

**Enclosures:** (U) Memorandum dated November 07, 1996 from the Assassination Records Review Board (ARRB) forwarding the security clearance for Mr. Masih.

**Details:** (U) The John F. Kennedy Assassination Records Collection Act of 1992 mandated that all federal agencies process their records related to the assassination and provide all the original documents to the National Archives for public review. The FBI has been working with the ARRB established by this act to complete the project. Other ARRB employees have access to the FBI building to accomplish this job.

(U) On 11/07/96, Mr. Phil Golrick, FBI team leader of the ARRB, advised the JFKTF that Mr. Joseph Masih will be reviewing FBI records in the JFKTF space and will need access to the FBI building on a daily basis.
