Synopsis: (U) New York is requested to provide detailed status regarding two references to JFK core subjects as soon as possible.

(U) Derived From VG-3 Declassify On: 10/01/2017

Details: (U) Pursuant to the John F. Kennedy Assassination Records Collection Act of 1992 (JFKARCA), any materials considered assassination records must be made available to the National Archives and Records Administration (NARA) in their original form. The JFKARCA defines how the FBI may now postpone certain information, but the originals are still sent to the NARA, to be maintained until the year 2017 when they are to be opened in full.

(U) In New York's response to the request of 7/8/98 by JFKTF to search all records for references to the JFK core subjects, the following ELSUR references were marked by New York with "?":

> (S) [105A-NY-3303-1] (8/6/62, re: Jack Rubenstein) [105-178326] (8/30/65, re: John F.Kennedy)

(U) JFKTF has documentation indicating that the 8/30/65 reference to John F. Kennedy may have been previously sent to Brian Fields at HQ in May of 1998. JFKTF is unable to locate this document at HQ and requests that New York provide any
