of 1992**Synopsis:** New York is requested to provide the JFK Task Force (JFKTF) with written clarification regarding the file numbers of the enclosed documents.**Enclosures:** Copies of 3 documents, with file covers and ELSUR sheets corresponding to each document.**Details:** New York has previously forwarded to JFKTF the originals of ELSUR records referencing John Kennedy. These documents are being reviewed and processed by JFKTF.

The enclosed documents appear to be the same as those identified on the New York ELSUR sheets attached to each file. On these ELSUR sheets, the original file number is crossed out and a new file number written in. The documents themselves do not reflect the new file number.

JFKTF requests that New York reply by EC no later than C.O.B. 9/17/98, setting forth specific details regarding the change of file number for each of the attached ELSUR references. The information currently provided by the ELSUR sheets is not sufficient for JFKTF to determine if the documents provided by New York are the same as the documents referred to on the ELSUR sheets. New York is requested to provide the following for each reference: the original file number, the new file number, the
