PURPOSE: To advise that on or about 1/26/96, the Assassination Records Review Board (ARRB) will advise us of their^o determinations on four FBI documents, previously postponed (redacted) to protect informants and to request Criminal Investigative Division (CID) and National Security Division (NSD) review the determinations and provide their positions on the determination as to appeal.

RECOMMENDATION: That CID and NSD addend this memorandum with their positions as to appealing the ARRB decisions and so advise the JFK Task Force (JFKTF) and Office of the General Counsel (OGC) by 1/29/96.
