Title: JFK RECORDS COLLECTION ACT OF 1992 (The Act)

Synopsis: New York is requested to conduct necessary research pursuant to the Assassination Records Review Board (ARRB) letter requiring the FBI's response by 10/21/96. New York is also requested to send pertinent files to Headquarters/JFK Task Force as soon as possible.

Details: The ARRB by letter dated 9/10/96 (copy available upon request) has requested that the FBI identify all information in FBI assassination records that the FBI believes is under court seal. The ARRB's interest in this matter, is to have the Department of Justice assist in petitioning the courts to unseal the records so the documents may be opened to the public as established by the JFK Assassination Records Collection Act (JFKARCA).

In accordance with the ARRB letter, the FBI must identify which jurisdictions/judges placed these records under court seal. In the case of electronic surveillance, the ARRB also seeks the location and the duration of the surveillance. Because the background information concerning these electronic surveillances are maintained in the Field Office, we are requesting that the field do the research necessary to respond to the ARRB's request. Therefore, the files will not be returned to your Field Office. Since the originals will be sent to NARA, copies of the files should be made for record purposes prior to their shipment to Headquarters. All files should be received at Headquarters no later than C.O.B. 10/11/96.
