Title: JFK RECORDS COLLECTION ACT OF 1992 (THE ACT)

Synopsis: Boston Division has located BS 92-118 Sub 3 which contains 7 volumes. Sub 3 is connected to BS 92-118 which is a 102 volume main file. The subject of the main file and Sub 3 is Raymond L.S. Patriarca Sr., who was the head of the New England "La Cosa Nostra" Organized Crime Family until his death in 1984. FBIHQ has instructed Boston to send seven (7) original serials from Sub 3 to FBIHQ by means of this communication. The Boston Division is unable to answer questions 1 through 4 set forth in referenced EC.

Reference: JFK Task Force EC to Boston dated 9/24/96 and a telephone call between MR. BRIAN FIELDS, JFK Task Force and Boston CDC CALLAHAN dated 10/1/96.

Enclosures: Enclosed for the JFK Task Force, FBIHQ are seven (7) original serials from Boston file 92-118 Sub 3 which were requested by Mr. Fields during referenced telephone call.

Details: The Boston Division has located BS 92-118 Sub 3 which is a seven (7) volume subfile connected to a 102 volume main file. The subject of both the main file and subfile is RAYMOND L.S. PATRIARCA SR., who was the head of the New England "La Cosa-Nostra" Organized Crime Family until his death in 1984.

On 10/1/96, CDC Boston advised MR. BRIAN FIELDS during referenced telephone call that the information contained in Sub 3 was provided by a symbol numbered source identified as BS 837-C*. CDC Boston requested that Boston Division Informant Coordinator, SA ROGER TARDIE attempt to locate any record regarding BS 837-C*. SA TARDIE advised on 10/1/96 that he caused a check to be made of his records, FBIHQ informant records and Boston Elsur records for any information on this source with negative results.

During referenced telephone conversation, MR. FIELDS asked CDC Boston to ship the following original serials from BS 92-118 Sub 3:

Serials: 107, 214, 217, 233, 362, 384, 407.

This is being done as an enclosure to this EC. It should be noted that these serials cover the time period from June 1962 until October 1964. The federal law authorizing the interception of wire and oral communications did not come into being until 1968. The Boston Division is unable to answer questions 1 through 4 set forth in referenced EC.
