RECORDS COLLECTION ACT OF 1992

Synopsis: Results of Miami Division search for records re Judith Campbell Exner per request of JFK Task Force.

Details: Re Bureau electronic communication to Miami, dated 6/19/97, requesting a search for records regarding Judith Campbell Exner, aka, to be sent to FBIHQ, JFKTF, in connection with a June 18, 1997 request of the Assassination Records Review Board (ARRB).

For the information of FBIHQ, a search of both the Miami Division confidential indices and electronic surveillance (ELSUR) indices disclosed no records regarding Judith Campbell Exner.

However, a search of the Miami Division general indices located two FOIPA request files regarding the subject. Per instruction of Carol Keeley, JFKTF, these files, 190-MM-53662 and 190-MM-54830, are not being forwarded to FBIHQ.
