

RECORDS COLLECTION ACT OF 1992 (THE ACT)**Synopsis:** Bonn's results to JFK Task Force request regarding Judith Campbell Exner in Bureau EC dated 6/19/97.**Details:** A search of Bonn indices regarding Judith Campbell Exner, Judith Immoor, Judith Campbell, Judith Eileen Von Immoor, Judy Campbell and Judy Exner revealed no records with an approximate birth date of 1934.

There is one record for a Judith Anne Campbell, DPOB 8/27/54, Clyde, New Zealand, who is the subject of file 163E-BN-11547, opened 11/24/92 and closed 2/25/93. The original file is located at FBIHQ, Information Resources Division, Legat Support Group.

Based on the difference in the birth dates, Judith Anne Campbell may not be identical to the subject of the inquiry. A further review of the file may be made through contact with the Legat Support Group at FBIHQ.
