Synopsis: (U) Synopsis: On 12/1 & 4/1997, the Assassination Records Review Board (the Board) formally advised by letter their determinations on FBI documents. This communication advises offices of the information the Board opened for release and may be subject to appeal.

(U) Enclosed are the two documents that the Board voted to open, with the information highlighted that the FBI requested to protect.

(U) On 12/1 & 4/1997, the Board formally advised the Details: FBI of determinations made on two FBI documents at their meeting of 11/17/1997. Included in the Board letter were lists of other documents that the FBI had agreed to the postponements or consented to release. As previously noted, the FBI and Board's staff review and negotiate the release of information from FBI documents. When the staff does not agree to postpone information that the Task Force personnel cannot release due to FBI policy, then the FBI must present evidence to justify the postponement of information.

two documents that opens the identity of Ricardo Anibal Morales Navarrete as a source. In the material being processed for release there are other documents that describe the death of the informant in Miami on 12/22/1982. Since the Board's instructions are to release any known deceased informant without evidence to justify the postponement, the Board asked for evidence to support the postponement. Based on the informants death and no known threats to relatives, the Board would not protect the informant because he did not meet their criteria of revealing "...the identity of a living person who provided confidential information..." or compromising "...the existence of an understanding of confidentiality currently requiring protection...and disclosure would be so harmful that it outweighs the public interest...."

 $(\mathcal{U})(x)$ Although the source testified at the Bosch Avila trial on federal charges of damaging foreign nations' vessels that were trading with Cuba in 1968, he continued providing information to the FBI. The source was also known as MM 1550-KS (Key Source) (IS - Cuba), who first started reporting information to the FBI in 1961. Initially he reported on information related to Cuban exiles in the United States and then focused on Orlando Bosch Avila and the Cuban Power Action Group's plans to blow up The information in the released documents concerns freighters. the informant's knowledge of Avila's actions that lead to his conviction. However, after 1968, the MM office continued to accept information from the source. In November 1974, the source moved to Venezuela and helped the Venezuelan government locate Avila who was a federal fugitive at the time. After this he accepted a position with the Venezuelan government and continued to provide information to the MM office about attempts of groups in Venezuela to overthrow the Cuban government.

The Board voted to release information that reveals the source. The information and informant were eventually used by federal authorities in the Avila trial. However, there are other documents from the source's file that will be reviewed as assassination records according to the Act. Most of the material relates to the bombing matters that eventually went to trial. However, some information is related to the time Avila was a fugitive in Venezuela and the MM source was passing that information to the MM office. The concern of this office is the information not yet addressed by the Board that reveals the MM source continuing his cooperation while he served as a Venezuelan official. Currently in the other documents, not yet reviewed by the Board, the only information proposed for postponement is an attempt to protect the MM informant's

cooperation while he was a Venezuelan official.

(U) Before the documents were reviewed by the Board, HERU contacted MM's Chief Division Counsel (CDC) Bill Dolde concerning the harm to any family or any other concerns the MM office could have regarding the release of the informant's identity. The opinion of MM was that should the Board vote to release the identity, then the MM Office would not object to the release. However, MM could not locate their file and did not know about the Venezuela information.
