This is in response to your letter with attachments dated February 16, 1995, received at this office on March 13, 1995, pertaining to investigative documents originating from the Royal Canadian Mounted Police (RCMP) involving the assassination of President John F. Kennedy.

The 448 pages received have been "date/number stamped" and, as requested, I examined the documents with the view of releasing as much information as possible due to the nature of and the time lapse since this incident occurred.

While I am governed by our Access to Information (ATI) and Privacy Acts (PA) with respect to what information is releasable under these statutes, I have released all innocuous personal information contained herein. Personal information such as the name, address, birth date, etc. of an individual who has not been, or has not been proven to be deceased for at least twenty years, must be protected. Although some of this information may be considered dated, it still constitutes personal/ identifiable information pertaining to the individual it relates to. Release of this information is not in the public interest and would be of benefit to no one. have highlighted those portions in pink and request that this information continue to be protected from release under subsection 6(3) of the President John F.
