synopsis: Detroit is requested to conduct a search for the document referred to by the enclosed ELSUR sheet.

Details: By telecall 8/98, Detroit advised the JFK Task Force (JFKTF) that it had located an ELSUR reference to Lee Harvey Oswald in file DE 100-13420. Detroit subsequently forwarded file 100-13420 to the JFKTF.

Upon review by the JFKTF, it was determined that Detroit file 100-13420 is not an ELSUR file and does not contain any reference to Lee Harvey Oswald.

JFKTF hereby forwards a copy of the ELSUR sheet regarding the Lee Harvey Oswald reference and requests that Detroit conduct a further search to locate the log or file containing this reference. JFKTF requests that Detroit forward the file, if located, in which the ELSUR reference appears, or, if the file cannot be located, respond by EC stating in detail whether the file has been lost or destroyed, as soon as possible but no later than C.O.B. 09/25/98.
