**Synopsis:** Chicago is requested to send requested files to Headquarters/JFK Task Force as soon as possible .

**Details:** The FBI has been requested to identify all information in FBI assassination records that the FBI believes is under court seal. The FBI must then identify which jurisdiction/judges have these records under court seal. The records listed below are maintained in your field office and require examination and response to the Assassination Records Reveiw Board (ARRB). The records will then be processed by the JFK Task Force for release to Archives.

Pursuant to the John F. Kennedy Assassination Records Collection Act of 1992 (JFKRCA) any materials considered assassination records must be made available to the National Archives and Records Administration (NARA) in their original form. The JFKRCA defines how the FBI may now postpone certain information, but the originals are still sent to the NARA, to be maintained until the year 2017 when they are to be opened in full.Therefore, the files will not be returned to your field office. Since the originals will be sent to NARA, copies of these files should be made for record purposes prior to their shipment to Headquarters. All files should be received at Headquarters no later than C.O.B. 1-27-97.
