The San Juan main file on ANTONIO VECIANA (Also known as ANTONIO CARLOS VECIANA BLANCH), D&POB 10/18/28, CUBA. is 105-10960, one volume, (1969-1975). SJ file 105-6133 is the file of the "Alpha 66" organization. The general indices search located several references to VECIANA. A cursory review of the 8-volume file indicated that ANTONIO VECIANA is mentioned in additional serials which were not indexed to him. San Juan is, therfore, forwarding the 8 volumes so the JFK Task Force can conduct a hand search on VECIANA. The indexed serials were 60, 94, 438, 482, 490, 625, 630, 639, and 679 (1962 - 1965).

Original serials 2-63-417 and 2-63-718 were also

indexed to VECIANA.
