Synopsis: Detroit is requested to check indices regarding Detroit files 92-447 and 92-438 Sub 2 to determine if there are corresponding Headquarters file numbers for each file.

Details: Pursuant to the John F. Kennedy Assassination Records Collection Act of 1992 (JFKARCA) any material considered assassination records must be made available to the National Archives and Records Administration (NARA) in their original form. In processing these records for release, the JFK Task Force (JFKTF) must consider these documents in their entirety.

A number of the original documents contained in Detroit files 92-447 (subject: Lawrence Thomas Phillip McHugh) and 92-438 Sub 2 (subject: Vito Giacalone) have information that has been blacked out. The JFKTF is charged with determining the content of that information if possible. The JFKTF is attempting to locate Headquarters files corresponding to the two Detroit files listed above. Headquarters is unable to search for corresponding Headquarters file numbers for field files without going through the field office itself. Therefore, the JFKTF requests Detroit to search the relevant indices and determine the corresponding Headquarters file numbers.
